#### ORDINANCE NO. 2 of 2017

AN ORDINANCE OF THE BOROUGH OF PLYMOUTH, LUZERNE COUNTY. PENNSYLVANIA VACATING TWO ROADS AND OPENING ONE ROAD IN ORDER TO COSOLIDATE THE WYOMING VALLEY WEST HIGH SCHOOL CAMPUS

WHEREAS, Wyoming Valley West School District has public streets separating the high school campus area and they are desirous of consolidating the high school campus;

WHEREAS, in order to assist the school distric in that goal the Borough will vacate two streets as herein after set forth and since the school district is the adjoin property owner to those streets the land being vacated will revert to them by operation of law;

WHEREAS, whereas the school district will deed to the Borough an area of land, which will be opened as a Borough Street in order that there is replacement of axcess to the property by the streets being vacated by the Borough;

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Plymouth Borough Council, for the reasons set forth above and incorporated herein, in accordance with 8 Pa.C.S. § 1731 of the Borough Code, hereby moves to vacate the following two borough streets:

- 1. Ashley Street (off of Wadham Street) a 50 foot Right-of Way as set forth in the attached boundary description and identified as Parcel No. 6 on the attached map; and
- 2. Walnut Street (Right-of-Way) as described on the attached boundary description and identified on a map attached hereto as Parcel No. 13;

Council moves to open the following street:

1. Walnut Street (relocated Right-of-Way) boundary description attached and identified on a map attached hereto as Parcel No. 12.

It is noted that the Wyoming Valley West School District are the owners of the property immediately adjacent to the two roads to be vacated and the road to be opened.

This ordinance will be effect as per section 3301.3 of the Borough Code.

ENACTED AND ORDAINED the 9<sup>h</sup> day of May, 2017 at a duly authorized regular meeting of the Plymouth Borough Council.

All that certain strip of land situate in the Borough of Plymouth, County of Luzerne, Commonwealth of Pennsylvania, bounded and described as follows:

BEGINNING at a set stone on the westerly side of Wadham Street (a/k/a Wadhams Street) as shown on a drawing in Block E, on plot of lots laid out in Plymouth Borough by the Lehigh and Wilkes-Barre Coal Company;

**THENCE** along lands of Wyoming Valley School District the following three (3) courses and distances:

- 1. South 81 degrees 10 minutes 00 seconds West a distance of 346.23 feet to a corner.
- 2. South 8 degrees 50 minutes 00 seconds East a distance of 50,00 feet to a corner.
- 3. North 81 degrees 10 minutes 00 seconds East a distance of 349.30 feet to a corner on the westerly line of Wadham Street.

THENCE along the westerly line of Wadham Street, North 8 degrees 51 minutes 39 seconds West a distance of 41.65 feet to an angle point in the line of Wadham Street;

**THENCE** North 28 degrees 52 minutes 00 seconds West along Wadham Street a distance of 8.89 feet to the point of BEGINNING and containing an area of 17,451.56 square feet or 0.40 acre of land.

## Plymouth Borough, Luzerne County, Pennsylvania

(Map reference: Parcel No. 13)

All that certain strip of land situate in the Borough of Plymouth, County of Luzerne and Commonwealth of Pennsylvania bounded and described as follows:

**BEGINNING** at a point on the westerly side of Girard Avenue, said point being located from the intersection of the southerly line of Shawnee Avenue with the westerly line of Girard Avenue by the following two (2) courses and distances:

- 1. South 28 degrees 26 minutes 00 seconds East a distance of 190.11 feet.
- 2. South 27 degrees 08 minutes 39 seconds East a distance of 171.33 feet.

**THENCE** along lands of the Wyoming Valley West School District, said line also being the northerly line of Walnut Street, South 61 degrees 08 minutes 00 seconds West a distance of 166.97 feet to a corner;

**THENCE** continuing along the same, South 28 degrees 52 minutes 00 seconds East a distance of 58.00 feet to a corner;

**THENCE** continuing along the same, South 61 degrees 08 minutes 00 seconds West a distance of 12.00 feet to a corner;

THENCE continuing along the same, South 28 degrees 52 minutes 00 seconds East a distance of 38.55 feet to a point of curve, said point also being on the westerly line of Wadham Street (a/k/a Wadhams Street);

**THENCE** through the right-of-way of Walnut Street by a compound curve turning to the right, an arc length of 14.72 feet, having a radius of 40.00 feet, a chord bearing North 18 degrees 19 minutes 17 seconds West, and a chord length of 14.64 feet, to a point of compound curve;

THENCE continuing through the right-of-way of Walnut Street on a compound curve turning to the right, an arc length of 38.71 feet, having a radius of 32.19 feet, a chord bearing of North 26 degrees 40 minutes 43 seconds East, and a chord length of 36.42 feet to the point of tangent;

**THENCE** continuing through the right-of-way of Walnut Street, North 61 degrees 08 minutes 00 seconds East a distance of 7.29 feet to a corner on the easterly line of Walnut Street;


THENCE along the easterly line of Walnut Street, North 28 degrees 52 minutes 00 seconds West a distance of 27.50' to the southerly line of Walnut Street;

**THENCE** along the southerly line of Walnut Street, North 57 degrees 16 minutes 51 seconds East a distance of 138.54 feet to a point;

THENCE through the right-of-way of Walnut Street, North 27 degrees 08 minutes 39 seconds West a distance of 24.76' to the place of BEGINNING.



## WALNUT STREET (RELOCATED RIGHT-OF-WAY)

### Plymouth Borough, Luzerne County, Pennsylvania

(Map reference: Parcel No. 12)

All that certain strip of land situate in the Borough of Plymouth, County of Luzerne and Commonwealth of Pennsylvania bounded and described as follows:

BEGINNING at a common corner on the easterly line of Wadham Street (a/k/a Wadhams Street) between the lands of Blythe Evans as described in deed book 1926 page 387and lands of the Wyoming Valley West School District;

THENCE along the lands of Blythe Evans, North 61 degrees 08 minutes 00 seconds East a distance of 148.50 feet to a corner on the westerly line of Girard Avenue;

**THENCE** along the westerly line of Girard Avenue, North 28 degrees 52 minutes 00 seconds West a distance of 72.50 feet to a corner;

**THENCE** continuing along the westerly line of Girard Avenue, North 50 degrees 29 minutes 14 seconds West a distance of 25.87 feet to a corner on the westerly line of the former Walnut Street:

**THENCE** through the former Walnut Street right-of-way, South 27 degrees 08 minutes 39 seconds East a distance of 24.76 feet to a corner on the southerly line of the former Walnut Street:

**THENCE** through the lands of the Wyoming Valley West School District the following three (3) courses and distances:

- 1. South 27 degrees 08 minutes 39 seconds East a distance of 20.33 feet to a point of curve.
- 2. On a curve turning to the right, an arc length of 26.19 feet, having a radius of 17.00 feet, a chord bearing of South16 degrees 59 minutes 38 seconds West, and a chord length of 23.68 feet.

3. South 61 degrees 08 minutes 00 seconds West a distance of 120.62 feet to a corner on the easterly line of Wadham Street;

**THENCE** through the former Walnut Street right-of-way the following three (3) courses and distances:

- 1. South 61 degrees 08 minutes 00 seconds West a distance of 7.29 feet to a point of curve.
- 2. On a curve turning to the left, an arc length of 38.71 feet, having a radius of 32.19 feet, a chord bearing of South 26 degrees 40 minutes 43 seconds West, and a chord length of 36.42 feet to a point of compound curve.
- 3. Continuing on a compound curve turning to the left, an arc length of 14.72 feet, having a radius of 40.00 feet, a chord bearing of South18 degrees 19 minutes 17 seconds East and a chord length of 14.64 feet to a point on the westerly line of Wadham Street.

**THENCE** along the northerly line of Wadham Street, North 61 degrees 08 minutes 00 seconds East a distance of 40.00 feet to the point of BEGINNING.

**CONTAINING** an area of 6,946.80 Square Feet or 0.16 Acres of land.

BEING part of the same lands conveyed to the Wyoming Valley West School District as recorded in the Office of Recorder of Deeds in Luzerne County Deed Book 1912 page 327.


