AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF PLYMOUTH, LUZERNE COUNTY, PENNSYLVANIA, ADOPTING A BEADE STREET FLOOD EMERGENCY PLAN

WHEREAS, the 300 block of Beade Street including the intersection of Beade and Ferry Streets and East River Street near Ferry Street historically has experienced potentially disastrous flooding as the Susquehanna River rises above flood stage;

WHEREAS, the Borough in order to give guidance to Plymouth Borough Officials, the department of public works, and emergency responders as well as identify steps in order to properly notify residents and in an effort to mitigate damages does hereby adopt a Beade Street Flood Emergency Plan as outlined in the attached document marked Exhibit "A", attached hereto;

NOW, THEREFORE, BE IT RESOLVED AND ADOPTED by the Borough Council of Plymouth, that Borough for the reasons stated above and incorporated herein does hereby adopt the "Beade Street Flood Emergency Plan", attached hereto as Exhibit "A" and incorporated herein to be followed by the Borough as enumerated therein.

This plan has been adopted as a guideline in the event of a flood emergency on Beade Street as a result of rising Susquehanna River levels. It's purpose is to give guidance to Plymouth Borough officials, the department of public works, and emergency responders and to identify the steps to be taken in order to properly notify residents and mitigate a disaster.

RISK ASSESSMENT

Historical events have identified a known issue in the 300 block of Beade Street including the intersection of Beade and Ferry Streets and East River Street near Ferry Street. The aforementioned section of the Borough has been known to experience potentially disastrous flooding as the Susquehanna River rises above flood stage.

CONSIDERATIONS

- Real-time river level
- Expected crest level
- Weather forecast
- Additional rainfall expected prior to river crest and in the days immediately following the crest

PREPARATION

Plymouth Borough Department of Public Works (DPW)

- Department heads and department members enroll in the USGS Water Alert program
 - o Alerts should be set with the following options:
 - Select Location: Plymouth, PA 18651
 - Data Type: Surface-Water Sites, Levels, Flow Data
- Monitor current and projected river levels
- Monitor weather forecasts
- Ensure all elements of the storm water system are maintained and operational
 - o Storm drains are:
 - in-tact and structurally sound
 - clear of vegetation and debris
 - Creeks and dams are:
 - clear of vegetation and debris
 - free-flowing
- Prepare traffic cones and barricades for use
