

RESOLUTION NO. 11 OF 2019

**A RESOLUTION OF THE COUNCIL OF THE BOROUGH
OF PLYMOUTH, LUZERNE COUNTY, PENNSYLVANIA, AUTHORIZING THE
SUBMISSION OF A GRANT APPLICATION UNDER ACT 71, LOCAL SHARE
ACCOUNT (LSA) TO THE COMMONWEALTH FINANCING AGENCY TO MAKE
INFRASTRUCTURE IMPROVEMENTS TO THE MAIN STREET**

WHEREAS, the Borough is eligible and desirous of applying for a grant from the Commonwealth Financing Agency under Act 71, Local Share Account(LSA) ;

NOW, THEREFORE, BE IT RESOLVED AND ADOPTED by the Borough Council of Plymouth, Borough of Plymouth, Luzerne County hereby requests a LSA Grant in the amount of \$366,666.00 from the Commonwealth Financing Authority to be used to make necessary repairs to the storm water and sewer infrastructure, improve pedestrian safety and public transportation facilities, enhance walkability and aesthetics throughout the Main Street of the downtown area of the Borough. In addition to repair and/or replace several uneven manholes on Main Street which cause drivers to swerve on the road and in some case cause the vehicles to cross over into oncoming traffic. The damaged storm water and sewer infrastructure cause cracks along the pavement which compromises the integrity of the roadway. In addition, the Borough wishes to enhance pedestrian safety and improve aesthetics by installing six (6) stamped crosswalks along Main Street. Furthermore, to work with the Luzerne County Transportation Authority to improve public transportation conditions by installing a new bus shelter on Main Street.

Be it further resolved, that the applicant does hereby designate Bill Dixon, Acting President of Council as the official to execute the initial application any documents necessary to submit and complete the same. After that the President of Council is authorized to execute all documents and agreements between the Borough of Plymouth and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant and the Borough Secretary to attest to his signature when necessary.
