RESOLUTION NO. 2 of 2014 A RESOLUTION OF PLYMOUTH BOROUGH, COUNTY OF LUZERNE, COMMONWEALTH OF PENNSYLVANIA, APPROVING TRANSFER OF RESTAURANT LICENSE NO. R-18025 INTO PLYMOUTH BOROUGH FROM LARKSVILLE BOROUGH LUZERNE COUNTY.

WHEREAS, Act 141 of 2000 ("the Act"), which amends the Commonwealth's Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section461 of the Liquor Code, if sales of liquor and malt or brewed beverages are legal in the municipality receiving the license;

WHEREAS, the receiving municipality issues a resolution approving the transfer of the license outside the municipality to inside the municipality;

WHEREAS, amendments to the Liquor Code stipulate that, prior to adoption of a resolution by the receiving municipality, at least one hearing be held for the purpose of permitting interested parties to state their concerns regarding the transfer of a restaurant liquor license into the receiving municipality; and

WHEREAS, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a restaurant liquor license into the municipality.

NOW, THEREFORE, BE IT RESOLVED, Arav18, LLC has requested the approval of the Board of Supervisors of Plymouth for the proposed transfer of Pennsylvania restaurant liquor license from Melynda A. Reese, trading as Rob's Pub, 232-234 Nesbitt Street, Larksville, Pennsylvania to its facilities within Plymouth Borough, located at 241 A West Main Street, a/k/a 241 West Main Street, Unit 1, a/k/a 255-257 West Main Street, Unit 1, which will be transferred to Arav18, LLC with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

BE IT FURTHER RESOLVED, that the Borough Council of Plymouth finds that after conducting a hearing for public comment on said transfer, immediately prior to acting on this resolution, the transfer of a restaurant liquor license into Plymouth by Arav18, LLC will not adversely affect the welfare, health, peace and morals of the municipality or its residents.
