## RESOLUTION

## No. 2 of 2016

## FIXING THE SALARIES AND WAGES OF EMPLOYEES OF THE BOROUGH OF PLYMOUTH FOR THE CALENDAR YEAR 2016:

BE IT RESOLVED by the Council of the Borough of PLYMOUTH, Luzerne County, Pennsylvania, and it is hereby resolved as follows:

- 1. That the retainer of the Borough Solicitor shall be fixed at Two Thousand Four Hundred Dollars (\$2,400.00) per year. Compensation for additional work shall be \$65.00 per hour and \$85.00 per hour for court attendance;
- 2. That the salary of the Borough Secretary/Treasurer (Clerk I) shall be fixed at Sixteen Dollars and .48 cents (\$16.48) per hour-\$29,993.60 Annual;
- 3. That the salary of the Borough Clerk II shall be fixed at Sixteen Dollars and .23 cents (\$16.23) per hour-\$29,538.60 Annual;
- 4. That the salary of a Part-time Police Officer shall be fixed at Thirteen Dollars and fifty cents (\$13.20) per hour
- 5. That the salary of a School Crossing Guard shall be fixed at Eight Dollars and .50 cents per hour (\$8.50) per hour;
- 6. That the salary of a Part-time Fire Truck Driver shall be fixed at Ten Dollars (\$10.00) per hour
- 7. That the salary of the Full Time Police Officers shall be determined upon passage of the Collective Bargaining Agreement. Current Officers receive different rates starting at \$11.56, \$12.38, and \$16.51 per hour.
- 8. That the salary of the Public Works Foreman shall be fixed at Sixteen Dollars and .57 Cents (\$16.57) per hour.
- 9. That the salary of the Public Works Laborers, shall be fixed at Fourteen Dollars (\$14.00) per hour
- 10. That the Part time wages for personnel substituting for regular Public Works Laborers shall be fixed at Fourteen Dollars (\$14.12) per hour for Plowing and minimum wage for seasonal employees;
- 11. That the salary of the Code Enforcement/Zoning Officer, shall be fixed at Thirteen Dollars and Forty Cents (\$15.00) per hour
- 12. That the salary of the Property Maintenance Coordinator, Thomas Craig shall be fixed at Eight Dollars (\$8.00) per hour-\$7,200.00 annual;
- 13. That the salary of the Borough Manager shall be fixed at Forty-Five Thousand (\$45,000.) per year unless contract is amended;
- 14. That the salary of the Borough Tax Collector shall be fixed at Three Thousand Dollars (\$3,000.00) per year;
- 15. That the Health Officer shall be paid One Thousand Dollars (\$1,000.00) per annum, to be paid quarterly;
- 16. That the compensation for President and Borough Council Members shall not exceed \$75.00 per month;

- That the compensation for Mayor shall be fixed at One Hundred Fifty 17. Eight Dollars and .33 cents (\$158.33) per month; That this RESOLUTION shall become effective January 1, 2016.
