## RESOLUTION NO. 3 of 2015 A RESOLUTION OF PLYMOUTH BOROUGH, COUNTY OF LUZERNE, COMMONWEAL TH OF PENNSYLVANIA, APPROVING TRANSFER OF LIQUOR LICENSE NO. R-15186 AND LID NO. 40800 INTO PLYMOUTH BOROUGH LUZERNE COUNTY FROM NANTICOKE CITY, LUZERNE COUNTY.

WHEREAS, Act 141 of 2000 ("the Act"), which amends the Commonwealth's Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section461 of the Liquor Code, if sales of liquor and malt or brewed beverages are legal in the municipality receiving the license;

WHEREAS, the receiving municipality issues a resolution approving the transfer of the license outside the municipality to inside the municipality;

WHEREAS, amendments to the Liquor Code stipulate that, prior to adoption of a resolution by the receiving municipality, at least one hearing be held for the purpose of permitting interested parties to state their concerns regarding the transfer of a restaurant liquor license into the receiving municipality, and

WHEREAS, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a liquor license into the municipality.

NOW, THEREFORE, BE IT RESOLVED, A-Sia Corp. has requested the approval of the Plymouth Borough Council for the proposed transfer of Pennsylvania liquor license No. R 15186 and LID No. 40800 from 34 West Broad Street, Nanticoke, Luzerne County, Pennsylvania to its facilities within Plymouth Borough, located at 39 East Main Street, Plymouth, Pennsylvania, which will be transferred to the aforesaid A-Sai Corp., with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

BE IT FURTHER RESOLVED, that the Borough Council of Plymouth finds that after conducting a hearing for public comment on said transfer, immediately prior to acting on this resolution, the transfer of a liquor license No. R 15186 and LID No. 40800 into Plymouth by A-Sai Corp., will not adversely affect the welfare, health, peace and morals of the municipality or its residents and will create jobs, revenue enhancement and dinning accommodations

for the Borough residents.

**BE IT FURTHER RESOLVED** that Plymouth approves, by adoption of this Resolution, the proposed intermunicipal transfer or both of the aforesaid licenses to A-Sai Corp., to be located at 39 East Main Street, Plymouth, Luzerne County, PA 18651 and that this approval is contingent upon and subject to approval of the transfer by the Pennsylvania Liquor Control Board.
