

RESOLUTION NO. 6 OF 2017

**A RESOLUTION OF THE COUNCIL OF THE BOROUGH
OF PLYMOUTH, LUZERNE COUNTY, PENNSYLVANIA, APPROVING THE
BOROUGH TO MAKE AN APPLICATION FOR THE WYOMING VALLEY WEST
SCHOOL DISTRICT FOR A GRANT IN THE AMOUNT OF \$135,476.00 FROM THE
PENNSYLVANIA GAMING LOCAL SHARE ACCOUNT UNDER THE
PENNSYLVANIA FINANCING AUTHORITY FOR THE PURPOSES OF MAKING
ROOF REPAIRS TO THE SCHOOL DISTRICTS HIGH SCHOOL SITUATE IN THE
BOROUGH OF PLYMOUTH**

WHEREAS, The Wyoming Valley West School District seeks the sum of \$135,476.00 from the Pennsylvania Gaming Local Share Account under the Commonwealth Financing Agency of the Commonwealth of Pennsylvania for the purpose of making necessary roof repairs to the school district's high school situate within the Borough of Plymouth, Luzerne County, PA, which will ensure an appropriate and suitable learning environment for the district's high school students, faculty, and staff; and,

WHEREAS, the submission of this request is appropriate and within the guidelines of the Pennsylvania Gaming Share Local Share Account, and

WHEREAS, approval of this submission will allow other district revenues to be used for other sound educational purposes,

WHEREAS, the Borough has students who attend the aforementioned Wyoming Valley West School District who will benefit, if the grant is provided to the school district to repair the roof;

WHEREAS, the Borough agrees with the School District that the most economical way to facilitate the roof repairs is for the Borough to file a joint application with the School District;

WHEREAS, the Borough has to be the applicant for the grant under the rules governing the grant;


NOW, THEREFORE, BE IT RESOLVED AND ADOPTED by the Borough Council of Plymouth, that the Borough hereby approves the filing of a of application by the Borough for the Wyoming Valley West School District and said application shall be filed in the name of the Borough to the Pennsylvania Gaming Local Share Account under the Commonwealth Financing Authority for the purpose of obtaining \$135,476.00 in order for the School District to make roof repairs to the High School located within the Borough of Plymouth, Luzerne County, Pennsylvania. The Council further authorizes, Gary Kochinski, President of Council to execute the application for the aforementioned grant as well as any and all documents required in association with said grant and the Borough Secretary to attest to his signature wherever necessary. The Borough is not accepting any financial liability or responsibility by filing this application and all such responsibility will remain with the Wyoming Valley West School District.
